- North Wales Police have active a Community Consultation Structure which encompasses a community led LGBT+ Group.
- North Wales Police regularly celebrate events to support the reporting of Hate Crime from the Transgender Community.
- North Wales Police use successful prosecution cases as a promotional tool to encourage further reporting of Hate Crime.
- North Wales Police Diversity Officers will attend local community groups to provide support and encourage victims of Hate Crime to report to North Wales Police.
